पर्सनल केयर क्षेत्र में पतंजलि सबसे ऊपर रहा। इस मामले में पतंजलि का स्थान डाबर और विको से आगे रहा। सर्वे के अनुसार ओरल केयर क्षेत्र में पतंजलि ने कोलगेट, डाबर और विको को पीछे छोड़ दिया।
होमकेयर में निरमा शीर्ष पर

देश की ईंधन मांग जुलाई में 7.3 प्रतिशत बढ़ी

नई दिल्ली। देश में ईंधन की मांग जुलाई में 7.3 प्रतिशत बढ़ गई। पेट्रोल और डीजल की खपत बढ़ने से कुल ईंधन मांग में इजाफा हुआ। पेट्रोलियम मंत्रालय के पेट्रोलियम योजना एवं विश्लेषण प्रकोष्ठ (पीपीएस) के अनुसार जुलाई में ईंधन की कुल खपत 1.70 करोड़ टन रही, जो एक साल पहले इसी महीने में 1.58 करोड़ टन थी। इससे पहले जून में ईंधन की मांग 8.6 प्रतिशत बढ़कर 1.79 करोड़ टन पर पहुंच गई। जुलाई में पेट्रोल की बिक्री 7.8 प्रतिशत बढ़कर 23 लाख टन रही, जबकि डीजल की खपत 4.8 प्रतिशत की वृद्धि के साथ 66 लाख टन पर पहुंच गई। इससे पिछले महीने पेट्रोल की बिक्री 15 प्रतिशत रही थी, जबकि डीजल की मांग स्थिर रही थी।

BENGALURU: Skipper Shreyas Iyer and senior batsman Ankit Bawne hit patient half centuries after early stutter as India A won the two-match series against South Africa A by 1-0 margin after the second 'Test' ended in a draw.
India A won the first four day 'Test' by an innings and 30 runs.
Starting the final day on 294 for 7, the Proteas added 25 runs losing the remaining three wickets to get all out for 319 in 98.2 overs.

Mohammed Siraj (4/72) and Ankit Rajpoot (3/52) shared bulk of the spoils while limited overs specialist Yuzvendra Chahal grabbed two for 84 in 22 overs. With a slender 26-run lead, India A finished their second essay at 181 for 4 with Iyer (65) and Bawne (64 no) steady-lyng the ship with a 86-run stand for the fourth wicket. Iyer hit four boundaries and four sixes in 103 balls while Bawne hit nine boundaries in 100
