WASHINGTON DC: Donald Trump not conceding defeat in the US election is "an embarrassment" and that "will not help the President's legacy," President-elect Joe Biden has said, asserting that his transition plans have remained unaffected and he has started talking to world leaders.



"Between now and then my hope and expectation is that the American people do know and do understand that there has been a transition. Even among Republicans... who voted for the president, I understand the sense of loss. I get that, he said.

Biden hoped that those who voted for him and those for Trump would come together.

"I think they're ready to unite and I believe we can pull the country out of this bitter politics that we've seen for the last five, six and seven years, he said. The President-elect said that he has already begun the transition. We are well underway.

Meanwhile, Biden on Tuesday had congratulatory calls with leaders of France, Germany, Ireland and the United Kingdom, during which in addition to bilateral issues they discussed efforts to address global challenges like COVID-19 together.
